HIGHLIGHTS FROM THE BIBICAL BOOK OF JOB

Job 1:12; Job 2:6-7: Job is faced with many troubles, and later blames God for causing his problems.

Job 1:19: Job's children are killed in a windstorm.

Job 2:9-10: God did not cause Job's troubles. God merely permitted Job to suffer. Still, Job trusted God. And Job refused to insult God.

Job 3:1-2; 3:11: Job curses the day he was born.

Job 9:17: Job accuses God of multiplying his wounds without cause.

Job 19:25-27: God was kind to Job, even when Job was suffering. God taught Job many things. Job learned that death is not the end of everything.

Job 22:4-11: Job's friends tried to help him, but gave poor advice. They did not think that God would allow an innocent person to suffer. So they thought that Job was guilty. They guessed that Job had done many wicked things.

Job 23:13-17: Job believed God was unfair, because he was still suffering.

Job 32:2-3: A man called Elihu, a man wiser than Job's other friends, spoke to Job and told him not to accuse God. Elihu was angry that the other friends had been cruel to Job.

Job chapter 38 to chapter 41: God shows Job the wonders of creation. While Job is preoccupied with his own suffering, God cares for the whole created order in ways that Job cannot fathom.

Job chapter 42: Then Job was sorry that he said the wrong things about God. Job prayed for his friends and God forgave them all. Job is blessed with a new family, wealth, and long life.
